- PRODUCT:** APPLICANT SHALL CLEAR ALL PRODUCT LIFTINGS IN ADVANCE AND NOT UNTIL AUTHORIZATION IS GIVEN. PURCHASES SHALL BE CHARGED TO APPLICANTS OPEN ACCOUNT. APPLICANT AGREES TO STAY WITHIN AUTHORIZED PAYMENT TERMS AND CREDIT LINE.
- PAYMENT:** FULL PAYMENT OF INVOICE IS DUE TEN (10) DAYS AFTER DATE OF INVOICE.
- INTEREST:** A FINANCE CHARGE OF 1.5% PER MONTH, ANNUAL PERCENTAGE RATE OF 18% WILL BE CHARGED TO APPLICANTS ACCOUNT ON ALL PAST DUE BALANCES, UNLESS OTHERWISE DIRECTED BY LAW.
- PLACE OF PAYMENT:** ALL PAYMENTS WILL BE MADE ACCORDING TO INVOICE INSTRUCTIONS, UNLESS OTHERWISE DIRECTED.

- CHANGE OF CREDIT TERMS:** GLOBAL GAS, INC. MAY CHANGE THE AFOREMENTIONED TERMS AND CONDITIONS UPON WRITTEN NOTICE TO APPLICANT.
- DELIVERY:** IF BUYER HAS ANY COMPLAINTS OR OBJECTIONS TO THE QUANTITY OR QUALITY OF PRODUCTS ARRIVING AT BUYER'S F.O.B. FAILURE TO NOTIFY SELLER OF THE COMPLAINTS OR OBJECTIONS WITHIN 24 HOURS FROM TIME OF DELIVERY SHALL BE A WAIVER OF ANY DEFECTS BY BUYER.
- TAXES:** THE AMOUNT OF ANY PRESENT OR FUTURE GOVERNMENTAL TAX, FEE OR DUTY (NOT INCLUDED IN THE PRICE OR OTHERWISE PAID BY BUYER) ON THE MANUFACTURE, SALE, USE OR HANDLING OF SAID PRODUCTS OR MATERIALS, SHALL BE PAID BY BUYER TO SELLER.
- GOVERNING LAW:** THIS AGREEMENT SHALL BE DEEMED TO HAVE BEEN MADE IN ENGLEWOOD, COLORADO, REGARDLESS OF THE ORDER IN WHICH THE SIGNATURES OF THE PARTIES AFFIXED; AND THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF COLORADO. THESE PARTIES AGREE THAT ANY CLAIM OR CONTROVERSY ARISING FROM OR RELATING TO, DIRECTLY OR INDIRECTLY, THIS AGREEMENT MAY BE LITIGATED ONLY IN THE STATE OF COLORADO AND THE PARTIES HERETO CONSENT TO BE SUBJECT TO THE JURISDICTION OF SUCH COURTS.
